

## Church of the Brethren, South/Central Indiana District

### **Congregational Loan and Grant Program Guidelines**

The South/Central Indiana District of the Church of the Brethren exists to support its member congregations in all aspects of ministry. Sometimes congregational ministries are held back by lack of start-up funds, by facility limitations or by the cost of maintaining aging structures. Most congregations have no choice but to borrow money from financial institutions at high rates of interest or to postpone key initiatives or projects until the funds have been raised. In an attempt to be faithful stewards of district resources, the South/Central Indiana District has established the Congregational Loan and Grant Program [the Program] as a resource to enable congregations to acquire, expand, or repair facilities, and to launch new/expanded ministries within the South/Central Indiana District. The Program is NOT intended to provide financial support for ongoing operations and/or routine facility/property maintenance.

#### **How the Program works:**

1. Congregations [including recognized fellowships] of the South/Central Indiana District can apply for loans or grants from funds set aside by the district board for that purpose.
2. The district's Loan and Grant Commission administers the Program according to the guidelines set forth in this document.
3. Approval of loan and grant applications will be dependent on the availability of funds and may be subject to considerations such as "greater need" or "first come, first served" at the discretion of the commission with guidance from the district board.
4. Loan and Grant requests for \$10,000 or less may be decided by the commission without district board review, but the commission must get approval from the district board to honor loan or grant requests for amounts in excess of \$10,000.
5. For loan or grant recommendations in excess of \$10,000 that are taken to the board for approval, a representative from the requesting congregation must attend the district board meeting to present their proposal and clarify any questions that may exist with respect to their proposal.
6. When a congregation's application is approved, the commission will work with the congregation to execute an agreement specifying the terms and conditions associated with the loan or grant.
7. Approved loans will be provided *at 0% interest* with the understanding that the loan will be repaid into the fund (as specified in the loan agreement) to again become available as a funding source for future loans and grants.
8. Approved grants will be provided *with no expectation of repayment* as long as the funds are used for the purposes outlined in the application. The grant acceptance agreement will identify the primary purpose of the grant, and will further specify conditions under which the receiving congregation agrees to *repay* any funds not used to fulfill that primary purpose.

9. Grant acceptance agreements will include a requirement that matching funds be provided by the congregation as a qualifying condition for receiving the granted funds. The percentage match will be negotiated when executing the grant acceptance agreement.
10. To help ensure wide availability to all congregations, individual congregations must wait at least two years from the date that a loan is fully repaid or a grant's objectives are fulfilled before applying for either a new loan or new grant.
11. Once the loan or grant request is approved and an agreement is executed, funds will be disbursed within four to six weeks.
12. Throughout the progress of the funded project, the commission will remain in contact with the receiving congregation to monitor progress of the project and to ensure that the terms and conditions of the executed agreement are being met.
13. Upon completion of the funded project, the congregation shall prepare a brief report to share the results of the work with the rest of the district. The report shall contain a summary of the project's final costs and a brief description of how the project has benefitted the congregation or enhanced the congregation's effectiveness plus any insights gained that would benefit other congregations. This report will be shared at District Conference.

The South/Central Indiana district board prays that this program will bless many congregations as we work together in ministry as brothers and sisters in Christ.
